### 2025 FULL MEMBERSHIP CONTRACT

1. This contract is between Great Companions LLC and \_\_\_\_\_ (human) and \_\_\_\_\_ (dog).
2. This contract is not refundable or transferable.
3. The fee is \$2750 for the calendar year 2025. Contract maybe prorated by month if started after January 1, 2025.
4. Contract pertains to group classes only (no private or semi-private lessons). Private lessons are a separate fee.
5. Student will take classes at the dog's level and not higher.
6. There is no limit to the number of classes being taken at a time.
7. A registration form will be completed for each class selected and submitted prior to the start date of the class. This is important to keep registrations fair and orderly. A team may not take a course unless a registration form is completed and submitted prior to the start of the course.
8. In the event that the team registers for a class and that class cannot be completed, another class can be registered for, but must be completed before registering for a subsequent class. This is to allow enough room in classes for everyone.
9. If a dog becomes reactive toward dogs or people during this membership, class options will be restricted to reactive dog classes until the dog is again able to handle other classes. A reactive dog will require a 4pack of private lessons (at a reduced rate of 50%) prior to joining a reactive dog class. Reactivity will be determined by Ali.

- 10. Should a dog become aggressive to people or dogs during the course of the year, the team will need to switch over to private lessons until the dog is determined to be safe in group classes. Readiness will be determined by Ali. Safety is the number one concern, for all involved.
- 11. Classes may be repeated throughout the year.

### **Liability Waiver**

I understand that attendance in a dog obedience training class is not without risk to myself, members of my family, guests who may attend, or my dog, because some of the dogs to which I (we) will be exposed may be difficult to control and may be the cause of injury and/or damage even when handled with the greatest amount of care.

On acceptance of my application to attend this dog obedience training class, I hereby waive, release, and agree to hold harmless, Ali Brown, Great Companions LLC, volunteers, and/or agents hereinafter referred to as Great Companions for injury and/or damage which I, my family, my guests, or my dog may suffer, including, but not limited to, any injury or damage resulting from the action of any dog(s) in the training session or on the training grounds.

In addition, I expressly assume the risk of such injury or damage while attending any training session, any other function of Great Companions, and/or while on the training grounds or surrounding areas thereto.

I hereby agree to indemnify, compensate, and hold harmless Great Companions, owners of the premises all claims asserted against the aforementioned, made by any person(s) accompanying me, or, any other person(s) attending any training session and/or other function of Great Companions, or while on the training grounds or surrounding areas thereto, as a result of any action by my own dog, that causes injury and/or damage.
